



## Waiver and Liability Release Agreement

We require all of our guests to read and sign the following waiver before embarking on any organized tour.

I hereby voluntarily release, discharge, waive and relinquish any and all claims or cause of action for personal injury, property damage or wrongful death occurring to me arising as a result of engaging in any activity of Hopkins Bay Resort, including, but not limited to, caving, rappelling, river cave tubing, jungle hiking, Kayaking, canoeing, biking, horseback riding, Marine tours touring archeological sites, vehicular transportation, or consumption of food, water or other beverages provided by Hopkins Bay Resort. I agree that under no circumstance will I or my heirs, executors, administrator, or assigns prosecute or present any claim for personal injury, property damage, or wrongful death against Hopkins Bay Resort, or its shareholders, employees, staff, management, agents, representative, guides, instructors, or any other person associated with the company.

### Cancellation Policy

I understand that all tours and transfers booked will be charged a 50% cancellation fee **IF** cancelled on the scheduled date of the tour.

BY SIGNING THIS WAIVER, I AGREE TO HOLD THE PARTIES LISTED ABOVE HARMLESS FOR ANY INJURY OR DEATH WHICH MAY OCCUR TO ME DURING ANY ACTIVITY, SERVICE, OR INSTRUCTION (WHETHER STATED ABOVE OR NOT) PROVIDED BY HOPKINS BAY RESORT. I RELEASE THE AFOREMENTIONED PARTIES FROM ANY CLAIM OR CAUSE OF ACTION THAT I OR MY ESTATE MAY HAVE FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH, ARISING FROM ANY AND ALL ACTIVITIES, SERVICE, OR INSTRUCTION PROVIDED, WHETHER THROUGH NEGLIGENCE OF AFOREMENTIONED PARTIES OR OTHERWISE.
